## **COURTHOUSE EXPANSION UPDATE**

Mr. Mike Giles, Chief Building Official presented Council with the floor design for the Court House expansion. He noted that the County has been granted relief for the required amount of parking through the Town of Orangeville Committee of Adjustment and now just waiting for the appeal process deadline. Council asked Mr. Giles to report back with the costing of adding a second floor over the sallyport.

## **HOSPITAL DELEGATION**

Mr. Cholly Boland and Ms. Hornseth from Headwaters Health Care Centre, addressed Council with background information in response to a November 12, 2009 resolution from County Council regarding a present proposal to move hospital beds from Shelburne to Orangeville site. Mr. Boland noted that the current proposal is for the improvement of patient care offered at Headwaters Health Care Center facilities. He informed Council that a public meeting will be held on Thursday, December 17, 2009 at Grace Tipling Hall, Shelburne to give residents an opportunity to provide input on the future of health services in Shelburne.

## **LEASE AGREEMENT WITH SHELBURNE FAMILY PHYSIOTHERAPY CLINIC**

The Shelburne Physiotherapy Clinic has been occupying 1560 square feet of space in the upper level of the Mel Lloyd Centre since April of 2004. Council approved a new three-year lease based on an increase to \$14.61 per square foot effective January 1, 2010 and an annual increase thereafter of three per cent. The clinic occupies 1560 square feet. The annual revenue for this lease is \$21,481.20.

Council authorized The Administrator of Dufferin Oaks to submit proposals for Central West LHIN funding as part of Year 3 of the Aging at Home Strategy for:

- A new Supportive Housing Program in Dufferin County
- An Enhanced Bridging you Home Program at the Lord Dufferin Centre
- A full time Seniors at Risk System Coordinator.  
(in partnership with the Ontario March of Dimes) for Central West LHIN funding for a Supportive Housing Program in Dufferin County.

### **CML HEALTHCARE LEASING SPACE AT MEL LLOYD CENTRE**

Council approved a lease with CML Healthcare for 300 square feet in the Mel Lloyd Centre. The company will use the space for the purpose of a medical diagnostic laboratory and specimen collection centre.

### **COUNTY TO PAY FOR FIRE RESUE CALLS ON COUNTY ROADS**

Council voted to reimburse local municipalities/fire boards for fire rescue calls on County Roads.

### **DEEP (Dufferin Eco Energy Park)**

Alter NRG, the proponent for the Energy from Waste facility asked Council to consider expanding the scope of the feasibility study to include a larger project option of 70,000 tonnes per year level. Council approved the request.
